

This included auditing of organisations, programs, health practice and health promotion resources, funding, and policies across each of these subtopics. As part of the ongoing Portal review process, 105 entries were removed from the Portal (either untagged, archived or unpublished due to lack of relevance).</p> <p>An estimated 12,440 broken links of publications, resources, and policies, across the HealthInfoNet websites (which includes the Environmental Health Portal) were checked for currency and updated during the reporting period.</p>

The same time in the previous year, 1 July 2022 to 30 June 2023, there were 29,873 pageviews and 21,111 sessions.</p> <p>As of September 2023, Google Analytics underwent a complete transformation in the way data are collected, analysed, and reported. The previous analytics system, known as Universal Analytics, primarily focused on page views and screen views. However, the new method, Google Analytics 4 (GA4), centres around event-based tracking.</p> <p>At the Australian Indigenous HealthInfoNet, we have undertaken efforts to adapt to this transformation and update our reporting methods accordingly. However, this process is still a work in progress. We are currently in the process of trialling alternative data criteria for metrics that are no longer supported under GA4.</p> <p>Therefore, due to the fundamental changes, it's important to note that data collected prior to September 2023 using Universal Analytics are not directly comparable to data collected after this date using GA4.</p>

Since the last report there has been ongoing negotiation between the Health/InfoNet Director Professor Neil Drew, Professor Dan McAullay, Head of Kurongkurl Katitjin at ECU, Professor Braden Hill Deputy Vice Chancellor Equity and Indigenous at ECU and Health/InfoNet Advisory Board members. In the reporting period it was resolved that the Health/InfoNet Advisory Board will be integrated into the Edith Cowan University institutional cultural governance structures with special responsibility for the Health/InfoNet. This will provide a more formal cultural authority structure and ECU will provide resources to support the Advisory Board. The integration process underway and will be completed in the next reporting period.</p> <ul style="list-style-type: none"> <li>• Quality control</li> </ul> <p>All quality control mechanisms, such as peer-review of knowledge exchange products and publications, were adhered to throughout the reporting period. All new staff were inducted and trained in Health/InfoNet policies, procedures and practices.</p> <p>The review of the Environmental Health Portal inclusion/exclusion criteria and subtopics has been completed and a draft report was forwarded to the Expert Reference Panel for Aboriginal and Torres Strait Islander Environmental health (ERPATSIEH) in July 2023.</p> <ul style="list-style-type: none"> <li>• Financial</li> </ul> <p>Regular due diligence oversight meetings were held between ECU Finance and the Health/InfoNet's Director and Business Manager.</p> <ul style="list-style-type: none"> <li>• Staffing</li> </ul>

All new staff received induction, orientation and training as required by ECU and the HealthInfoNet policies and procedures. All new staff were recruited in accordance with ECU HR policy and procedures.

- Information technology

The HealthInfoNet IT ecosystem continues to be managed within the ECU IT environment, with oversight by the HealthInfoNet's IT Manager. All performance indicators relating to IT performance were met and exceeded. We are part of an ECU internal audit and review of IT security practices which will ensure we remain best practice.

We continue to liaise with ECU IT experts to update our security software and protocols.

The HealthInfoNet has established an Artificial Intelligence (AI) working group to assess the impact of AI on HealthInfoNet operations. In addition, the HealthInfoNet IT Manager is a member for the ECU AI Working Group. The Director has been liaising with experts in the Aboriginal and Torres Strait Islander health sector to ensure that the cultural, ethical, moral and legal obligations for best practice use of AI in Aboriginal and Torres Strait Islander health are developed, adopted and adhered to.

## **Stakeholder Engagement**

The HealthInfoNet has continued to promote the Portal and newsletter in teleconferences, face-to-face meetings and stakeholder emails.

In the six-month period, the following engagement activities with stakeholders took place:

- email blasts on the publication of the *Overview of Aboriginal and Torres Strait Islander health status 2023*, *Summary of Aboriginal and Torres Strait Islander health status 2023* and associated powerpoint presentations in March 2024 (which included a section on Environmental Health); production in house of a new short 'take a tour' of the portal video was also promoted to stakeholders
- a presentation on the Portal and HealthInfoNet café/exhibition stand at the NATSIEH conference in Melbourne, May 2024
- a presentation on the Portal at the IFEH World Congress in Perth, May 2024
- promoting the portal in all face-to-face meetings with organisations in Perth, Melbourne, Adelaide, Brisbane, Sydney and Canberra
- two HealthInfoNet Roundtables; one in Brisbane and Canberra. These were well attended with 45-50 attendees representing a cross section of peak bodies in the sector and there were networking opportunities among attendees. The Environmental Health Portal was promoted during the Director's presentation and the Environmental Health Portal brochure was included in the attendee kits.

In the reporting period, we also exhibited at six other conferences (not environmental health specific) and the Portal was promoted at all of these.

Stakeholders include the national Advisory Board members, partners, funders, Consultants, NACCHO and affiliates, Government agencies, NGOs, peak bodies and professional associations.
