

The same time in the previous year, 1 July 2023 to 30 June 2024, there were 35,689 pageviews and 23,344 sessions. Hence, there has been a 2% decrease in pageviews and no change in sessions from the last reporting period.</p> <p>The average session duration during the reporting period was 04:09 (minutes:seconds) which represents a 1% increase from the last reporting period. Overall, these findings suggest that usage of the Environmental Health Portal has remained steady.</p>

Cultural appropriateness of Environmental Health Portal is assessed via regular feedback processes with users, ERPATSIEH members and members of the Health/InfoNet advisory board who represent several Aboriginal and Torres Strait Islander peak health bodies.</p> <p>Since the last reporting period, AIH have appointed their first Aboriginal Director, Professor Bep Uink. It is noted that concepts and expectations of cultural governance have shifted across the years that Health/InfoNet has been operational. In response, Professor Uink has initiated a Working Group on Cultural Governance to establish the process that Health/InfoNet will follow to move to full Aboriginal and Torres Strait Islander governance. An invitation to join the Working Group was sent to all members of the Health/InfoNet Advisory Board, however, members indicated an inability to join the Working Group due to time constraints and it was decided that Working Group members should be ECU staff only. Currently members are Professor Uink, Professor Dan McAullay, Head of Kurongkurl Katitjin at ECU, and Professor Braden Hill, Deputy Vice Chancellor Equity and Indigenous at ECU. The Working Group is currently undertaking an assessment of AIH current and future cultural governance using the Australian Indigenous Governance Toolkit. There has been ongoing negotiation between Professor Uink, Professor McAullay, and Professor Braden Hill, about how future AIH cultural governance can be integrated into the ECU institutional cultural governance structures with special responsibility for the Health/InfoNet. This will provide a more formal cultural authority structure and ECU will provide resources to support the Advisory Board. The Working Group process and integration process is underway and will be completed in the next reporting period.</p> <ul style="list-style-type: none"> • Quality control <p>All quality control mechanisms, such as peer-review of knowledge exchange products and publications, were adhered to throughout the reporting period. All new staff were inducted and trained in Health/InfoNet policies, procedures, and practices.</p>

AIH conducts a yearly meeting with the Expert Reference Panel for Aboriginal and Torres Strait Islander Environmental Health (ERPATSIEH) to ensure appropriateness and utility of content on the Environmental Health portal.

- Financial

Regular due diligence oversight meetings were held between ECU Finance and the Health/InfoNet's Director and Programs Manager.

- Staffing

All new staff received induction, orientation and training as required by ECU and the Health/InfoNet policies and procedures. All new staff were recruited in accordance with ECU HR policy and procedures.

- Information technology

The Health/InfoNet IT ecosystem continues to be managed within the ECU IT environment, with oversight by the Health/InfoNet's IT Manager. All performance indicators relating to IT performance were met and exceeded. We are part of an ECU internal audit and review of IT security practices which will ensure we remain best practice.

The Health/InfoNet continues to liaise with ECU IT experts to update our security software and protocols.

Building on the Health/InfoNet's establishment of an Artificial Intelligence (AI) working group, the Health/InfoNet has partnered with Professor Ray Mahoney and Dr Andrew Goodman from the CSIRO Australian e-Health Research Centre to discuss potential ethical uses of AI in the Health/InfoNet. This partnership saw Health/InfoNet attending a focus group discussion with the Centre to provide insights into questions that need to be asked and addressed for the ethical update of AI in Aboriginal and Torres Strait Islander health. Findings from this report have been published in a co-authored report with the Centre.

Stakeholder Engagement

The HealthInfoNet has continued to promote the Portal and newsletter in teleconferences, face-to-face meetings and stakeholder emails.

In the 12-month period, the following engagement activities with stakeholders took place:

- email blasts on the publication of the *Overview of Aboriginal and Torres Strait Islander health status 2024, Summary of Aboriginal and Torres Strait Islander health status 2024* and associated powerpoint presentations in March 2025 (which included a section on Environmental Health)
- production in house of the new series of Healthy Homes factsheets was also promoted to all stakeholders as well as environmental health specific organisations and state/territory bodies in September 2024. The factsheet series was also promoted in the December issue of the Directors Communique.
- a presentation on the Portal and HealthInfoNet at the WA EHA conference in Perth, April 2025
- promotion of the Portal in all face-to-face meetings with organisations in Perth, Melbourne, Adelaide, Sydney and Canberra
- two HealthInfoNet Roundtables in 2025; one in Adelaide and Perth. These were well attended with 45-47 attendees representing a cross section of peak bodies in the sector and there were networking opportunities among attendees. The Environmental Health Portal was promoted during the Director's presentation and the Environmental Health Portal brochure was included in the attendee kits.

In the reporting period, we also exhibited at six other conferences (not environmental health specific) and the Portal was promoted at all of these.

Stakeholders include the national Advisory Board members, partners, funders, Consultants, NACCHO and affiliates, Government agencies, NGOs, peak bodies and professional associations.

AIH Online Community Consultations:

A series of Online Community Consultations were held in May 2025. The purpose of the consultations was to seek input into a Strategic Plan for the Australian Indigenous HealthInfoNet.

There were nine distinct consultation groups:

1. Regional, rural, and remote communities
2. Tertiary students
3. Higher education and research institutes
4. University librarians
5. Aboriginal Community Controlled Health Organisations (ACCHOs)
6. Aboriginal Health Workers and community members
7. Environmental health workforce
8. Justice sector professionals
9. Health practitioners.

There were 74 attendees:

98.6% of attendees 'strongly agreed' that the Health*InfoNet* represented good value for money.

Each cohort provided valuable input during the consultations. The importance of the Health*InfoNet* was highlighted in addressing the gap in Indigenous health. Some key themes that emerged were:

Health*InfoNet*'s positive and sustained impact on Indigenous health outcomes:

- easy access to resources
- centralised knowledge hub
- provision of education and research tools
- cultural safety and education
- positive community and workforce impact
- providing visibility and awareness of best-practice.

Key areas where attendees wanted further support included:

- supporting workforce capacity building
- worker training and upskilling
- cultural safety
- allyship and applied skills
- Indigenous Data Sovereignty (IDS) knowledge
- implementation of IDS principles
- Aboriginal Health Workforce specific training and leadership
- Short, succinct and timely summaries of 'what is working' in the Aboriginal health sector.

Quotes from the Environmental Health Stakeholders:

- *"I am a university lecturer and Healthinfonet provides great Indigenous focused course content for students - which is great as we Indigenise the curriculum"*
- *"easy access to consolidated quality resources"*
- *"[more information needed on]... Referral pathways/linkages from clinical to environmental health".*

This feedback shows the high usage, satisfaction and engagement by stakeholders with the AIH. All suggested components will be considered in the upcoming AIH Strategic Plan.
